



### 2009 Tinsley Harrison Award Winner



The Tinsley Harrison Award is awarded each year to the first author of the best original manuscript published in *The American Journal of Medical Sciences*.

The 16th annual Tinsley Harrison Award was presented to Katima Phisitkul, MD of Texas Tech University Health Science Center by Dr. David W. Ploth, Editor-in-Chief of *The AJMS*. Dr. Phisitkul was also awarded a \$1,000 check from Lippincott, Williams, Wilkins, publisher of *The AJMS*.

The title of the winning paper was “Continued Smoking Exacerbates but Cessation Ameliorates Progression of Early Type 2 Diabetic Nephropathy”.

## SSCI Young Investigator Awards

The SSCI Young Investigator Awards are offered to recognize and encourage excellence in investigation by physicians and medical students during research training.

**Eligibility:** Medical students, combined MD/PhD students, interns, residents and post-doctoral physicians who are in research training or were in research training June 2009 are eligible. Post-doctoral research training may be considered to extend for a period of up to three years and time spent in strictly clinical fellowships need not count against this.

The applicant must be the first author of the abstract submitted in competition for the award and will plan to present the paper during the scientific sessions of the Southern Regional Meetings. Please note that it is not necessary for the senior author to be a member of the SSCI.

**Procedure:** Abstracts will be submitted for the 2009 Annual Meeting of the Southern Society for Clinical Investigation according to the usual procedure described in the instructions on awards consideration accompanying the abstract form.

**Deadline:** The submission deadline of the abstracts and application for the SSCI Young Investigator Award is **October 16, 2009.**

**\*\*Please note that nomination letters from the senior investigator or mentor and the Division Director or Department Chairman are required and should include a statement of the candidate's role in the study. In order to be eligible for consideration of these awards, the nomination letter(s) should be uploaded on the website at the time of abstract submission.**

The past 12 months has seen significant changes to *The AJMS*: A new front cover, revamping the inside layout, new article types, i.e: Images, Historical Perspectives and the quarterly CPC from Texas A&M. In addition, we were pleased to publish 3 symposia in 2008. Annual submissions continued to increase once again in 2008 with 583 submissions; up from 480 submissions in 2007. It's only mid-August, but we are confident we will exceed last year's numbers as submissions are presently at 463!

Despite the present economic situation, *The Journal* continues to prosper. Royalty revenue paid to the SSCI increased from approximately \$102,000 to \$130,000. Royalty income is derived from several sources: page charges, bulk sales of entire symposia and other issues to organizations, and downloads of current and archived articles from the web. One of the many benefits of being a member of the SSCI is free access to articles, both in print format and online.

*The AJMS* is in the forefront of electronic medical publishing thanks to our publisher, Lippincott, Williams, Wilkins. Recently, LWW released our new and improved website, which offers a new "look" and many new enhancements for users, with more to be released in the coming months.
